

Food Grade Statement

(PPS350, Rev. 1.1, 02/18, KMC)

Acetone (propan-2-one) and Acetone products sold by Greenfield Global USA Inc. are suitable for materials and articles intended to come into contact with food and use in food and beverage applications as specified in following regulations:

- COMMISSION REGULATION (EU) No 10/2011 Acetone is listed in the latest version of COMMISSION REGULATION (EU) No 10/2011 on plastic materials and articles intended to come into contact with food. Acetone (FCM Substance No 119) is listed in ANNEX I, Union list of authorized monomers, other starting substances, macromolecules obtained from microbial fermentation, additives and polymer production aids. Use as additive or polymer production aid (Table 1). There are no restrictions and/or specifications indicated.
- EU Directive 2009/32/EC Acetone is listed in Annex 1, Part 1: Extraction solvents which may be used during the processing of raw materials, of foodstuffs, of food components or food ingredients. Acetone meets the requirements of Article 3 (b) in that it does not contain more than 1 mg/kg Arsenic and 1 mg/kg Lead. Extraction solvents to be used in compliance with good manufacturing practice. The use of Acetone in the refining of olive-pomace oil is forbidden.
- Commission Regulation (EU) No 872/2012 Acetone is listed as flavoring substance in foodstuff (FL No: 07.050 – JECFA No: 139 – CoE No: 737).
- Resolution AP (2004)1 Acetone is included in C. List 1 Additives of resolution AP (2004)1 on coatings intended to come into contact with foodstuffs. There are no restrictions and/or specifications indicated.
- EUPIA exclusion list Acetone is not included in the exclusion list of solvents issued by the European Printing Ink Association.
